TEMPLARS partnered with the Sickle Cell Foundation Nigeria (SCFN) to drive sickle cell awareness in Lagos, Nigeria.

The partnership involved a blood walk and sickle cell awareness walk in Lagos state. The aim of the Sickle Cell Awareness Walk was to displace existing public misconceptions about sickle cell. The Sickle Cell Awareness Walk helped provide compatible blood type to people living with sickle cell and sensitised the public to better understand that sickle cell is not a death sentence. It was also aimed at educating people with sickle cell on how to survive the stigma, as well as manage the medical condition.

The Blood Walk garnered support and encouragement for people living with sickle cell and involved blood donations to persons with sickle cell by persons willing to donate.

Adopt-a-Prisoner *Project*

In furtherance of its belief that everyone is deserving of excellent legal services, especially indigent individuals, the Firm established the Templars' Adopt a Prisoner Project. The project has the sole goal to provide pro-bono legal services (to the extent practicable) to inmates of selected correctional facilities in Lagos state, with the pioneer beneficiaries being the inmates of the Female Correctional Center, Apapa, Lagos State. Selected inmates will receive legal services at no cost till their cases are effectively wrapped up.

While providing legal assistance is at the core of the initiative, the project also involves the provision of welfare items to the inmates in order to cushion the notoriously terrible living conditions they are subjected to in the prison. To this end, and in preparation of the launch of this project, the Firm started a monthly welfare drive to gather welfare items for the benefit of the inmates.

The welfare drive was an overwhelming success as the Firm generated over N4,000,000 (Four Million Naira) internally to purchase items for the inmates. Additionally, the Firm received donations of clothing items, sanitary pads, toiletries, baby clothes, food items etc., from generous members of staff.

On Saturday, 18 November 2023, the Firm carried out its first welfare visit to the Female Correctional Center, Apapa, Lagos State. The event saw a massive turnout of TEMPLARS' members of staff led by Partner Zelda Akindele and Chief Operating Officer Debisi Omole.

The Templars delegation was warmly received by the prisons' officials and the inmates who could scarcely hide their joy when informed of the largesse provided by Templars.

The Templars delegation intimated the inmates of the Adopt a Prisoner Project, answered questions regarding the project and what to expect from Templars going forward and equally provided responses to various other queries the inmates had. It was a deeply emotive experience for all delegates and exhibited Templars' commitment to ensuring that we live in a world that is fairer for all persons, even those who may currently live behind bars.

Healthy Heart Foundation

TEMPLARS formed a partnership with the Healthy Heart Foundation to enhance its efforts in reducing preventable deaths emanating from cardiovascular diseases and providing top-notch cardiovascular care in Nigeria. This collaboration was aimed at making cardiovascular interventions more affordable and accessible to Nigerians by supporting the foundation's research center, learning center, and surgical operations.

To date, with TEMPLARS' assistance, the Foundation has conducted 110 consultations, 20 heart repair surgeries, and 15 replacement surgeries. This partnership underscores TEMPLARS' commitment to improving healthcare access and outcomes in Nigeria, aligning with the Foundation's mission to address the growing burden of cardiovascular diseases in the country.



Women At Risk International Foundation (WARIF)

No Tolerance March

WARIF is a non-profit organisation established to raise awareness and address the high incidence of sexual assault, rape, and human trafficking occurring amongst young girls and women in our society.

Last year, our TEMPLARS family joined over 1,000 men, women and children who participated in the "NO TOLERANCE" March to speak up and take a stand against rape, sexual violence, child abuse, trafficking and other harmful practices in our communities.

The Fair Justice Initiative The Fair Justice Initiative (FJI) remains dedicated to improving the lives of prison inmates in Ghana, focusing on combating discrimination and fostering rehabilitation.

KEY INITIATIVES

Education & Skills Training: Prioritizing rehabilitative education and skills training for inmates to aid their societal reintegration.

Painting Project: A collaboration with the Judith Ellen Foundation and Fidelity Bank Ghana volunteers, enabling female inmates at Nsawam Female Medium Security Prison to express themselves through art, promoting personal growth and community.

Farm Project: In partnership with Holland Greentech, we've established a vegetable farm at Nsawam Female Medium Security Prison to combat malnutrition and provide educational opportunities. The project also generates funds to sustain itself through the sale of 60% of the produce.

Justice Stakeholder Workshop: Hosted with Justice Defenders and chaired by Chief Justice Kwasi Anin-Yeboah, the workshop discussed introducing in-prison paralegalism to enhance justice access and support inmate rehabilitation.

MEDICAL SUPPORT

Provided essential medication to inmates at Nsawam Prisons and covered medical costs for specific cases, including surgery for an elderly inmate and support for a pregnant inmate.

MOVING FORWARD

FJI continues to champion fair justice and support for inmates through practical initiatives and partnerships, focusing on education, health, and rehabilitation.
